Co-Impact Gender Fund grant applications are open!




At the Generation Equality Forum in June 2021 Co-Impact announced the development of their second fund – the Gender Fund. This Fund commits to raise and grant US \$1 billion over the next decade to advance gender equality and women's leadership in the Global South. They are now inviting applicants to submit concept notes for the first round of grants made through this Fund. What Will it Take to Achieve Universal Social Protection?

Covid19's severe impact on the poorest communities is unprecedented. While Social protection remains a human right, the international Social Protection Community is now at a crossroads as to how social protection will be understood in a world reeling from pandemic shocks. This article from BRAC underscores the need for governments to make these systems more inclusive, comprehensive and multisectoral.



Do larger cash transfer interventions and graduation approaches improve longer run outcomes more cost effectively?

A <u>recently published</u> thought provoking study by Development Impact Evaluation Group (DIME) at the World Bank measures the cost-effectiveness of cash transfer and graduation programs. The paper challenges the conventional wisdom that the presence of poverty traps implies larger interventions are more cost effective. The study considers two approaches to increasing intervention size in the context of temporary unconditional cash transfers—larger transfers (intensity), and adding complementary graduation program interventions (scope). The theoretical and empirical results from the study ignites a much needed debate on the "cost-effectiveness" aspect with respect to increasing intervention size.



Balancing Stability and Transition : A First Assessment of *Regra de Permanência* in Bolsa Familia

Conditional Cash Transfers in middle income countries like Brazil face a daunting task in striking the right balance between promoting graduation through labor market insertion and ensuring stability in the program. Bolsa Familia "Regra de Permanencia" rule allows families to continue receiving the Bolsa Familia benefits for up to 24 months, even if their per capita income goes above the program's eligibility line.
