The Partnership for Economic Inclusion (PEI) is a global partnership hosted by the World Bank's Social Protection and Jobs Global Practice that aims to increase the earning opportunities and well-being of extremely poor and vulnerable people by accelerating systems change to massively scale-up effective household interventions.



A <u>recent paper by Naila Kabeer</u> explores the experiences of 40 participants in two of the original graduation pilot projects supported by CGAP and the Ford Foundation. Kabeer's qualitative research considers the participants' experience before, during, and after the projects, launched by Trickle Up in India and Orangi Charitable Trust in Pakistan, and offers observations on nearby projects that were assessed with randomized controlled trials and featured in <u>Science</u> <u>magazine</u> in 2015.

Making graduation programs work for children

Thirty policymakers, donors, and researchers gathered on May 2 at the British Academy in London to discuss how graduation programs hold potential for improving children's lives. Organized by the Centre for Social Protection at IDS, representatives from IDS, the London School of Economics, PEI, and Save the Children presented. Building on longitudinal data from BRAC's Targeting the Ultra Poor Program in Bangladesh, Oriana Bandiera from LSE finds that the beneficiaries' children accumulate more human capital and have better health and more schooling than the control group. Adolescent boys over 16 also start climbing the job ladder, replacing casual labor with both skilled work and work on land acquired by their mothers through the program. Qualitative research from IDS's Pathways to Stronger Futures in Haiti project suggests that the economic inclusion of mothers can help break the intergenerational transmission of poverty but also highlights the tension between engaging in income-generating activities and providing care for young children. 


Skoll World Forum

An ecosystem event at this year's Skoll World Forum brought together leaders from eight organizations including The BOMA Project, BRAC, Concern Worldwide, Fundación Capital, PEI, Trickle Up, Trinity College, and Village Enterprise to discuss the intersection between graduation approaches and women's economic empowerment. Panel members agreed that new research

underway will reveal more and all agreed that gender-transformational design and delivery are critical to meet the global commitment to gender equality.

The Transfer Project Conference


